## **Hot Mixed Asphalt Paving Services**

The Town of Farmington is seeking proposals for a qualified contractor to provide Hot Mixed Asphalt Paving services. Services will include providing adequate materials, labor, traffic control and equipment to perform, hot mixed asphalt paving in various locations throughout the Town of Farmington as directed by the Town Board. New hot mix asphalt material should consist of 12.5 mm 58-28s Surface course material with tack coat in-between layers.

### **Asphalt Overlay Roads**

The scope of work will include a minimum .75" thick pavement surface skim (hot mix wedge), topped with 2.25" of surface hot mix asphalt overlay with tack coat. Proposal should include all mill/wedges required to match existing driveways and/or cross road pavements.

- 1. Scenic Dr- From western pavement edge of N. Paradise Dr. to eastern pavement edge of Maple Tree Rd.
- 2. Windy Acres Dr. from northern pavement edge of Scenic Dr. to southern dead end of Windy Acres- Matching existing pavement edges.
- 3. Forest View Rd- from northern pavement edge (ROW) of HWY 28 to new pavement edge of E. Moraine Dr.
- 4. Tomahawk Dr- from northern pavement edge of Hwy A to dead end of Tomahawk Dr.-Matching existing pavement edges

#### Patch/Wedge Overlay Area

**Wedge-**The scope of work will include a minimum .75" thick pavement surface shim (hot mix wedge), topped with 2.25" of surface hot mix asphalt overlay with tack coat. Proposal should include all mill/wedges required to match existing driveways and/or cross road pavements.

**Patch-** The scope of work will include a 1.75" asphalt binder course over subgrade (gravel material), topped with 2.25" of surface hot mix asphalt overlay with tack coat.

1. Meadow Rd- Patch area of culvert replacement and Wedge Overlay from eastern pavement edge of Trading Post Trail to the east for a distance of 2,250ft. See map
