# AN ORDINANCE ESTABLISHING SPEED LIMIT ON PORTION OF BOLTONVILLE RD., SCENIC DR. AND PARK RD. THE TOWN OF FARMINGTON, WASHINGTON COUNTY, WISCONSIN

WHEREAS, the Town of Farmington, Washington County is reducing the speed limit from 35miles per hour to 25 miles per hour of portions of Boltonville Rd., Scenic Dr. and Park Rd. within the town of Farmington.

WHEREAS, the town has reviewed and considered the request from town residents to reduce speed limits on these town roads,

# NOW, THEREFORE, THE TOWN BOARD OF THE TO\VN OF FARMINGTON, WASHINGTON COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

#### **SECTION I-AUTHORITY**

The Town Board of the Town of Farmington has the specific authority under s. 349.11, Wis. stats., and general authority under its village power under s. 60.22, Wis. stats., to adopt this ordinance.

# SECTION II - SPEED LIMIT-BOLTONVILLE RD.

A speed limit of 25 miles per hour on Boltonville Rd. in the Town of Farmington from a location beginning 2,400 ft. north of the centerline of Bolton Dr. to State Hwy 144/28 is hereby established.

## SECTION III - SPEED LIMIT-SCENIC DR.

A speed limit of 25 miles per hour on Scenic Dr in the Town of Farmington between State HWY144/28 and Bolton Dr. is hereby established.

#### SECTION III - SPEED LIMIT-PARK DR.

A speed limit of 25 miles per hour on Park Dr. in the Town of Farmington between Scenic Dr. and Bolton Dr. is hereby established.

### **SECTION IV - SIGNAGE**

Pursuant to s. 349.11(5), Wis. Stats., the Town Chairperson, or his or her designee, shall place appropriate traffic signs indicating the established mile per hour speed limit on Boltonville Rd, Scenic Rd. and Park Rd.

# **SECTION V - VIOLATION**

No person may operate any vehicle on Boltonville Rd., Scenic Dr. and Park Rd. in violation of the established mile per hour speed limit. Any violation shall be subject to penalties under s. 346.60, Wis. Stats.

### SECTION VII - EFFECTIVE DATE

This ordinance is effective on publication or posting.

The town clerk shall properly post or publish this ordinance, as required under s. 60.80, Wis. Stats.
